CCRW Texas Legislative Report

May 2019

HB 3: State sales tax proposal:

A proposal to pay for long term school district tax cuts by raising the state sales tax by 1% appears to be dead in the water.

State Senator Larry Taylor stripped the sales tax swap from HB 3 in the Senate version of the school finance bill.

Instead, the upper chamber voted to create a Tax Reduction and Excellence in Education Fund to pay to lower school district taxes. A Senate working group came up with a plan to get about \$3 billion from a few sources, without raising taxes, including diverting money from the severance tax on oil and gas extraction and collecting money from an online sales tax. Taylor said that could pay to lower school district taxes statewide by <u>10 cents per \$100 valuation</u>, saving the owner of a \$250,000 home about \$250 a year. Goes to Conference Com.

SB 9: Curb mail ballot voter fraud & illegal voter assistance.

HJR 38: Allows Texans to vote on a constitutional amendment prohibiting a state income tax. Coauthor-TX State Rep. Dr. Greg Bonnen

HB 1631: Ban red light cameras in Texas

HB 303: Spaceport for Ellington Field. Sponsor: Senator Larry Taylor.

Allow Houston to create a Spaceport Development Corporation to spur the development of the Houston Spaceport at Ellington Field. Passed

HB 1888: Polling Place Hours

<u>HB 1900, 4534</u>, (3038, 31223, 3961 – *left in committee*) Relates to TWIA Put a hold on raising TWIA premium rates until 2021. Passed House.

HB 1110: Expand Medicaid for women following childbirth from 60 days to one (1) year.

<u>**HB 1769**</u>: Alert system for missing adults. Sponsor: Dr Greg Bonnen. Passed. It will now go to Governor Abbott for signature.
