#### March Guest Speaker

Elected in November 2014, Texas Comptroller Glenn Hegar serves as Texas' chief financial officer, treasurer, check writer, tax collector, procurement officer and revenue estimator.

As Comptroller, Hegar oversaw state and local revenue matters during the 83rd legislative session and was instrumental in cutting \$1 billion in taxes for Texas taxpayers and businesses. As a business owner, Comptroller Hegar knows firsthand that individuals, not government, will make

better decisions with their hard-earned tax dollars and in turn help boost the economy.

Hegar also served as chair of the Sunset Advisory Commission, working to eliminate inefficiency in government agencies. In that role, he abolished six state agencies, saving taxpayers over \$160 million dollars in the process. As a former member of the Texas House of Representatives and the Texas Senate, Hegar worked on a wide range of common-sense solutions that impact everyday citizens, such as public education, transportation, tax cuts, property tax reform, water issues and tort reform.

Hegar earned a Bachelor of Arts degree from Texas A & M. He earned a Master of Arts and his law degree from St. Mary's University and a Master of Laws from the University of Arkansas.

Hegar is a sixth generation Texan, who grew up farming land that has been in his family since the mid-1800s. His upbringing taught him the core values of character, honesty, integrity and hard work. These are the same values that he and his wife, Dara, work to instill in their three young children: Julia, Jonah and Claire.

#### The 2020 Census, Apportionment and Redistricting: Civics 101

The United States is divided into 435 House districts. Each district elects one person to serve in the U.S. House of Representatives.

The <u>Census</u> counts the population in their homes where they live every 10 years. <u>Apportionment</u> means using the census count to determine the number of seats each state gets in the House of Representatives. If the population of a state has grown larger, a state may get more seats in the House – if the population is smaller, a state may lose seats.

<u>Redistricting</u> happens when population changes call for redrawing Congressional district lines.

#### Census Day is April 1, 2020.

Timeline:

- Invitations will be mailed to every household between March 12-20. Although the term invitation is used, participation is required. A reminder letter will be sent March 16-24.
- If you don't respond, reminder post cards will be mailed March 26-April 3.
- A reminder letter and paper questionnaire will be sent April 8-16
- A final reminder postcard will be sent April 20-27.
- If you still have not responded, a census worker will follow-up in person.
- The Census Bureau expects to release the results by December 31, 2020, but is required to do so by January 25, 2021.

#### Clear Creek Republican Women General Meeting February 7, 2020 at La Brisa – League City

The meeting was called to order by Kari Long, President at 12:02

The Invocation was given by Chaplain Mary Blackwell.

Pledges to the US and Texas flags were led by Scott Bowen.

Kari Long recognized elected officials and candidates in attendance.

Brittany King - VP Membership - announced that there are 38 Full and 31 Associate members.

Kari Long asked if there were any corrections to the minutes published in the Newsletter and there being none, the Minutes of the General Meeting of January 10, 2020 were recorded as published.

Roxann Lewis, Treasurer reported that the beginning balance in Texan Bank on December 1, 2019 was \$22,979.38 and the ending balance on December 31, 2019 was \$21,392.73. The beginning balance on December 1, 2019 in Wells Fargo was \$4,014.68 and the ending balance on December 31, 2019 was \$4,472.27. The balance in Texan Bank on January 1, 2020 was \$21,392.73 and the ending balance on January 31 was \$20,880.84. The beginning balance in Wells Fargo on January 1, 2020 was \$4,472.27 and the ending balance on January 31, 2020 was \$3,592.57.

Kathie Nenninger gave the Internal Review Committee Report for 2019 records. The Financial Review committee met on January 30, 2020. Members were Chrissy Crews, Kari Long, and Kathie Nenninger. Our CCRW Treasurer, Brittany King and PAC Treasurer Melissa Johnson were available in the event there were questions.

The review committee concluded that the CCRW Treasurer's records were in good order and that Brittany King did a superb job of keeping the receipts and invoice records with careful attention to detail utilizing Quick Books. The books balanced at the end of the year 2019 and there were no discrepancies. There were two areas in the review that called for the new treasurer, Roxann Lewis, to be added to the bank signature cards and will be completed very soon. It was noted that most receipts of funds are collected by CCRW Membership VP.

It was recommended that someone not having signature authority on the accounts to review the bank reconciliations at least quarterly. Also, an item added by TFRW this year, suggests that our TEC reports be reconciled to the financial statement for the corresponding period. These Procedures will be presented and discussed at the next board meeting in order to incorporate them.

Kari Long introduced the speaker, David Balat, Director of Texas Public Policy Foundation, Healthcare Division. Mr. Balat spoke about the many issues and problems with our Healthcare system.
